



Program Specifics & Application Instructions

This program is open to all landowners and organizations within Cass County, North Dakota unless specified otherwise below. Landowners that can be better covered by other programs within the District or NRCS will be referred as needed. Practices already covered under other programs may not be eligible for additional cost-share.

The Cass County Soil Conservation District Cost-share Assistance Application for Urban Conservation Practices applies to the following practices,

- **Water Conservation Irrigation Home Systems Including**
 - Drip irrigation (*home lawns/gardens*)
 - Rain barrel system including,
 - Adding on or improvements to existing rain barrel system
 - Community education course and materials for first barrel
 - Compost tumbler system including,
 - Improvements to existing home composting system
 - Community education course and materials for first compost tumbler
- **Forestry Conservation Practices Including**
 - Arboretum
 - Living snow fence
- **Alternative Landscape Practices Including**
 - Rain garden/Bioswale
 - Xeriscape
 - Pollinator garden or pollinator habitat improvement
 - Little Free Garden (***60% reimbursed with proof of cost***)
 - Low mow/alternative turf grass planting
 - Grass planting using native grass/forb mixes
 - Pocket Prairie Initiative
 - Pervious paving (*poured-in-place pervious concrete/asphalt; block or concrete modular pavers; grid pavers*)
- **Urban Riparian Area Improvement Projects Including**
 - Native planting for riparian forest improvement (**Red River/Sheyenne River Only*)
 - River bank stabilization project (**Red River/Sheyenne River Only*)
 - Riparian habitat improvement (**Red River/Sheyenne River Only*)

Cost-share grants will be awarded to a limited number of landowners and organizations per year until cost share funding for each practice has been exhausted for the fiscal year. This program reimburses 60% of approved costs, unless noted otherwise, associated with implementing particular conservation practices up to a maximum dollar amount as seen below. **Customers will be charged 40% of the cost for the practice up front.**

Customers are expected to install the practice within the instructed growing window, and submit copies of all project related receipts to the District. A final site evaluation will determine if all appropriate measures were taken and if any further dues are owed at that time. If practices are not installed during the advised window of time, the remaining 60% of the project cost will be charged to the customer.

Customers should be aware that only those costs incurred after the contract and site photos have been completed will be eligible, no reimbursement is offered for efforts or projects done prior to this application. The exception is the Little Free Garden. Upon proof of supply purchase, 60% of the cost will be reimbursed.

Applications will be accepted on a continual basis **and will be pending board approval.** After submission of your application, you will receive a confirmation email of our receipt of your application. After submission, please allow up to one month to be notified of our funding decision. If a cost-share grant has been awarded, we will follow up with a cost- share contract and site visit. Once this contract and site visit process has been completed, we will begin to provide technical assistance to assist in planning your practice to the best of our ability. Although we provide multiple avenues of assistance; procurement of materials, installation, labor and maintenance work including all liabilities are the responsibility of the customer. Funded practices should be installed within the growing window and should be maintained for at least five years. If the practice(s) is/are removed prior to 5 years, the customer is responsible for cost-share repayment according to the amount of the pro-rated scale. (1% pay back per each month under the 5 year commitment)

If your application is not funded, Cass County Soil Conservation District still offers free technical assistance for these and other conservation practices to all residents of Cass County, North Dakota. Please contact us for more information.
